Procedures, Terms and Conditions

Details about admission process and formalities can be obtained from the office.

1. Refund of Fee

Fee once paid is not refundable for any reasons whatsoever.

Withdrawal Rules

- Application for withdrawal is to be made on a prescribed proforma available in the school office. No child can be withdrawn till a written request from
 parents is put up. A one month notice period or one month notice fee is required for withdrawal.
- Clearance must be obtained from the laboratory and library incharge before applying for withdrawal.
- Transfer Certificate will be issued after one week of the receipt of the application and clearance of all dues.

3. Bus Rules

- Request for using the school bus must be made at the beginning of the session i.e. April. No request will be entertained during mid-session.
- It will be the sole responsibility of the parents to escort the pupil to and from the fixed bus stops. The bus facility is extended at the sole risk and responsibility of the parents.
- Any suggestions or complaints should be reported to the transport in-charge. Parents are expected to treat the bus staff courteously. Do not give
 instructions to bus staff, driver or conductor.
- The bus shall stop at the pre-decided stops only for picking up children. Those who are late will miss the bus at their own risk.
- For security reasons, students who miss the bus from the assigned stop will not be picked up from any subsequent stop.
- In case a Parent/ Guardian is not present at the bus stop to pick up the child while being dropped back, the child will be driven back to the school.
- The school does not own the bus service but will introduce the parents to the vendors. Vendors are carefully selected but school is not responsible for any mishap related to the transport service.

4. Right of Alteration / Modification

Management reserves the right to modify, after and / or include any other terms and conditions that may be deemed fit in the interest of the institution.

Medical Facility

- The school is well equipped to deal with most of the emergencies.
- The school provides facilities of First-Aid only.
- The school cannot be held responsible for injury suffered by a child. No reimbursement of charges would be made towards any medical treatment.

6. Procedure for Fee Payment

- Fee is charged as per schedule given in the fee card.
 - (a) Fee at the time of admission and installments thereafter shall be deposited directly in Bank of Maharashtra, Talegaon (SP) branch, into the account of Innovative Minds School of Execellence, AC no. 60156734210, IFSC code MAHB0000734

Incase where cheque is issued for any payment is dishonored by Bank for reason of insufficient funds, a penalty of Rs. 300/- will be charged and if dishonored due to any other reason a penalty equal to Rs. 200/- will be charged. The name of the child is liable to be struck of the rolls, if the fee is not paid by the last date of the said months.

Note: Only the Registration Form should be submitted at the time of Registration. Forms are required only after the child is granted admission.
